

Camper Behavior Contract

As an applicant to St Mary's Summer Camp, I, _____ agree to the following concerning participation at the camp or at any other location visited as part of the camp program.

- I agree to not use or bring or have in my possession alcohol or drugs other than those approved or specified by the camp doctor/ nurse, director, or partaking of any other prohibited substance.
- I also agree to leave at home any items which are weapons or weapon-like.

A violation of the above will result in immediate expulsion from camp with loss of tuition at the parent's effort and/or expense and a subsequent counseling session(s) with the local priest, youth and parents.

- I agree to respect the authority of the camp staff, following their directions and accepting their decisions. This includes instructions for "lights out," as well as to cease any other activities for whatever reasons that they might have.
- I agree to attend all camp church services as designated by staff, to arrive on time, and to respectfully remain there until dismissed.
- I agree to respect the needs and feelings of others, to show kindness to all that I come into contact with, and to help out whenever I can.
- I agree to not bring, use or have in my possession any tobacco products.
- I agree to bring only those items approved by the camp directors (see camper's packing list) and to leave home those things which are neither appropriate nor allowed by the camp. This includes IPODs/MP3 & other music players, cell phones, computers, game systems, and luxury items and that if I have one in my possession, it may be confiscated for the duration of camp.
- I agree to refrain from any and all unchaste language, gesturing, and behaviors. This includes using profanity, engaging in or seeking to engage in sexual behavior, dressing or behaving immodestly, or in general, willfully giving into or leading others into temptation.
- I agree to refrain from any and all violence, including physically or verbally abusing my fellow campers, bullying, fighting, yelling, and in general losing my temper.
- I agree to respond to all harsh words, threats, taunts, insults, and attacks without returning like for like, "eye for an eye," but to seek a peaceful resolution to the problem, including but not limited to seeking the help of camp staff and/or simply walking away from the situation.
- I agree to respect all property including housing, athletics, outdoor and indoor facilities that belong to the camp and St. Mary's Camp Program as well as the personal property belonging to my fellow camp -mates.
- I agree to respect the 11pm camper curfew and not be out of my cabin unless accompanied by a staff member.
- I agree to respect the views, opinions, beliefs, religious or otherwise, of my fellow campers, even if I do not agree with them.
- I agree to avoid coupling and going off to talk alone (or to do anything else as couples, for that matter). Regardless of the nature of the relationship, camp is a time for group inclusion & fellowship.
- I agree to pursue the fun and enjoyment of this camp experience whole-heartedly and in the spirit of Christian fellowship!

A violation of the above will be dealt with according to the severity and may include, but not be limited to, being prohibited from participating in some or all activities. a call to a camper's parents, expulsion from camp with loss of tuition, reimbursement for damages and/or being prohibited from returning to this camp program.

I have read and understand the above Camper's Behavior Contract and agree to follow these policies during my participation in the St. Mary's Summer Camp program. I understand that should I fail to comply with these policies; the consequences as stated above will apply.
